# CYBER SECURITY: A WORKSHOP & AWARENESS SESSION

Kathmandu, Nepal, 14th January 2024 - The Nepal Association of Tour and Travel Agents (NATTA) organized a workshop and awareness session titled "Cyber Security Significance in the Travel Industry" at the Auditorium Hall of the Nepal Tourism Board, Bhrikuti Mandap, Kathmandu, on 29th of Poush 2080 / 14th of January 2024.

The event was aimed at addressing the current issues of various cyber-related challenges faced by the travel trade sector in Nepal. The session was graced by the presence of Superintendent of Police Mr. Pashupati Kumar Ray from the Nepal Police Cyber Bureau, along with representatives from Global Distribution System (GDS) service providers Sabre Nepal, Amadeus Nepal, and Travelport Galileo Nepal. More than 80 participants attended the session. SP Mr. Pashupati Kumar Ray extended his remarks and presentation in the session, followed by presentations from the GDS service providers Sabre, Amadeus, and Galileo. NATTA President Mr. Ramesh Thapa added his remarks to address the session, and Mr. Kumar Mani Thapaliya Secretary-General of NATTA, moderated the entire session. A question-andanswer session was held for the participants.
