NATTA SUGGESTS PROGRAMS FOR ANNUAL BUDGET & PROGRAM, GON

(April 7,2014)

A meeting was convened by the Ministry of Culture, Tourism & Civil Aviation to the above affect on last Monday, the 07th April to discuss about the Programs and Budget of the GON likely to come out very shortly. The Second VP of NATTA Mr. CN Pandey participated in the meeting. And on Wednesday, 09th Apr. NATTA forwarded a letter to Mr. Purna Chandra Bhattarai, Joint Secretary at MOCTCA, suggesting the Ministry to put up the contents of the suggestions in the Budget & Program of the GON. They include: Setting up of a permanent Tourist Bus Terminal in Kathmandu & other major destinations of Nepal, holding of International Travel Mart in Nepal, erecting bicycle route for tourists in Raniban across the Phewa Lake in Pokhara, Granting of certain percentage of TSF to NATTA for promotion of tourism, waiving of royalty realized from the spiritual tourists at Damodar Kunda, waiving of import taxes on vehicles imported by travel agents, simplify the process of tourism transport registration in Kathmandu & Pokhara and finally Open the passage across Lomanthan and set up immigration office.
